

COMMUNICATIONS

The park can be accessed by Junction 11 of the M4 which provides good transport links to London, Heathrow and Slough to the East and Newbury, Swindon and Bristol to the West.

Green park also benefits from a fast track bus service which links the Business Park to Reading Train station, these services run every 10 minutes with a journey time of 12 minutes. Reading train station provides quick access to London Paddington (25 minutes) with this station becoming more connected when Crossrail is introduced.
